UPDATE ITEMS

- 6. Regional Housing Needs Assessment (RHNA) Allocation Methodology Updates SGVCOG Principal Management Analyst, Caitlin Sims, provided an update regarding Southern California Association of Governments' (SCAG) proposed RHNA allocation methodology. SCAG Regional Council recently approved and submitted the draft RHNA allocation methodology to the California Department of Housing and Community Development (HCD). HCD must provide feedback on the submitted methodology within 60 days and the SCAG Regional Council can then submit an appeal if needed. It is expected that the finalized methodology will be officially adopted in October 2020.
- 7. San Gabriel Valley Regional Housing Trust SGVCOG Principal Management Analyst, Caitlin Sims, provided an update regarding the San Gabriel Valley Regional Housing Trust. A draft joint powers agreement for the Trust has been developed and the document was distributed to the Trust's stakeholders for review and feedback. It is expected that cities can begin joining the San Gabriel Valley Regional Housing Trust in early 2020.

PRESENTATIONS

8. Housing Legislative Updates

HCD representatives, Melinda Coy and Greg Nickless, provided a detailed presentation on the housing bills that were recently signed by Governor Newsom. Ms. Coy and Mr. Nickless covered key bills such as AB 68 (Ting), AB 881 (Bloom), SB 13 (Wieckowski), and SB 330 (Skinner) and recommended cities to update their accessory dwelling unit (ADU) ordinances in accordance to the new state guidelines. HCD will be releasing an ADU technical assistance memorandum in the next few weeks to assist cities with the ADU ordinance revision process.

Discussions:

• A member inquired about contents that should be included in the updated ADU ordinance. Mr. Nickless responded that the ADU technical assistance memorandum will include specific recommendations and language that should be included in the updated ADU ordinance. The memorandum is expected to be posted on the HCD website in the next few weeks. In the meantime, Mr. Nickless recommended cities to review section 1.5 of the AB 881 (Bloom) as a reference.

DISCUSSION ITEMS

9. SB 743 Implementation & San Gabriel Valley Regional Transportation Analysis Model SGVCOG Chief Engineer, Mark Christoffels, provided a presentation on SB 743 (Sterinberg, 2013). Cities must adopt new vehicle miles of travel (VMT) measurements by July 1, 2020. Additionally, Mr. Christoffels mentioned the effectiveness of cities combining efforts to establish regional VMT analysis models and cited examples from the Western Riverside Council of Governments and cities in northern Orange County. The estimated cost of developing a VMT analysis model for the San Gabriel Valley region is approximately \$150,000 to \$200,000, which would be evenly divided between participating cities.

Discussions:

- A member commented that developing a regional VMT analysis model would be an excellent idea for the region and recommended that the RFP process should allow for individual city analysis.
- Another member commented that there is only a limited amount of consulting firms available to provide this service for the region.
- Most committee members expressed interest in participating in the development of a regional VMT analysis model.

BACKGROUND

AB 101 – the FY 2020 budget trailer bill related to housing and homelessness – makes \$250 million available to regions, cities, and counties for planning activities to accelerate housing production and facilitate implementation of the Regional Housing Needs Allocation (RHNA). Half of this funding will be allocated to the State's metropolitan planning organizations (MPOs) to support activities that will increase housing planning and facilitate local housing production. In southern California, the Southern California Association of Governments (SCAG) will receive approximately \$50 million.

SCAG staff is currently developing its Regional Early Action Planning (REAP) program. They recently distributed a survey to jurisdictions soliciting feedback on their local housing priorities in order to better align SCAG's funding framework and available resources with community needs and local planning capacity. SCAG staff also extended an invitation to its subregional partners to provide additional feedback on recommendations on how to structure the program to meet local needs in each subregion. SGVCOG staff has scheduled a call with SCAG staff to provide input.

SGVCOG staff intends to recommend that, to the extent possible, funding should be allocated directly to jurisdictions, rather than administering a competitive grant program, similar to its existing sustainability planning grant program. In addition, SGVCOG staff intends to request that funding be allocated to support the development of planning documents and other activities that will support the launch of the San Gabriel Valley Regional Housing Trust (SGVRHT). These include the development of a housing project pipeline to more clearly define the region's specific need for funding.

At the Planners TAC meeting, SGVCOG staff is requesting input from the Planners TAC on additional sub-regional needs and recommendations that should be communicated to SCAG staff.

The remaining \$125 million will be allocated to local jurisdictions based on population:



Population	Maximum Funding Award
Less than 20,000	\$65,000
20,000 - 59,999	\$150,000
60,000 – 99,999	\$300,000
100,000 – 299,999	\$500,000
300,000 – 749,999	\$750,000
750,000 +	\$1,500,000

Jurisdictions must submit a request for their allocation of funds by July 1, 2020. Funding must be expended by December 31, 2023.

BACKGROUND

Throughout the past few months, the SGVCOG City Managers' Steering Committee, Transportation Committee, Public Works Technical Advisory Committee, and Planning Directors' Technical Advisory Committee discussed the possibility of establishing a regional transportation vehicle miles of travel (VMT) analysis model in order to comply with upcoming SB 743 (Steinberg, 2013) mandates for cities to adopt VMT thresholds by July 1, 2020. All four committees expressed support for this regional endeavor and recommended SGVCOG staff to solicit interest from member agencies. Cities were given the opportunity to submit letters of interest to SGVCOG until December 31, 2019.

Based on the submissions, the following 26 cities expressed interest to participate:

RE: COUNTYWIDE TRAFFIC REDUCTION STUDY

RECOMMENDED ACTION

BACKGROUND

As part of its mission to provide a world-class transportation system within Los Angeles County, the Los Angeles County Metropolitan Transportation Authority (Metro) strives to double the usage of transportation modes other than commuters driving alone by 2028. The agency conducted a traffic reduction study to explore ways to dramatically improve equity, mobility, and environmental outcomes to achieve Metro's strategic goals and investigate feasibility and framework for testing and implementing pricing strategies to reduce traffic.

Various types of congesting pricing models were explored, including:

- **Cordon Pricing:** Creating a boundary around a central district and charging vehicles to cross that boundary
- VMT Pricing: Charging drivers based on vehicle miles travelled (VMT)
- **Corridor Pricing:** Pricing all lanes on all roads within a specific corridor with high traffic congestion but a viable public transit alternative

Metro Office of Extraordinary Innovation Senior Director, Tham Nguyen, will provide a detailed presentation on the traffic reduction study's highlights and project milestones at this meeting.
