6. FY 2018-2019 Financial Audit Roger Martinez from Vasquez and Company provided a presentation on this item.

Key Discussions/Questions:

- A Governing Board member inquired about access of the FY 2018-2019
 Financial Audit Report and recommendations regarding information
 technology (IT). Mr. Martinez responded that members of the Governing
 Board will have access to the document and that the IT operations are related
 to all policies and procedures of the agency. SGVCOG Executive Director,
 Marisa Creter, also mentioned that recommendations from the audit,
 including IT components and services, are being implemented in the COG's
 operations.
- Another Governing Board member inquired about the transition procedures
 of the Finance Director position. Mr. Martinez responded that current
 SGVCOG Finance Director, Rey Alimoren, developed the closing
 procedures for the position. The closing procedures include a checklist of
 tasks to be completed at the end of a financial reporting period to ensure the
 accuracy of each financial report.
- A Governing Board member offered expertise for assisting with the COG's auditing operations should the need arises. Mr. Martinez also commented that an individual with IT background in governance can be extremely helpful.

PRESIDENT'S REPORT

SGVCOG President, Cynthia Sternquist, shared that Governor Newsom recently ordered all Californians to wear face coverings in public settings, including public transit and medical care facilities.

EXECUTIVE DIRECTOR'S REPORT

SGVCOG Executive Director, Marisa Creter, reminded Governing Board members that the July Governing Board meeting will be cancelled if the Governing Board approves the resolution to cancel the meeting in the Consent Calendar. Additionally, Ms. Creter acknowledged SGVCOG employees for adapting to the existing circumstances and continuing to serve the San Gabriel Valley.

GENERAL COUNSEL'S REPORT

SGVCOG General Counsel, David DeBerry, provided an announcement regarding the U.S. 9th Circuit Court of Appeals denying a preliminary injunction sought by Southern California Recovery Centers that would have prevented the City of Costa Mesa from enforcing ordinances regulating where and how many sober living facilities may operate inside city limits.

COMMITTEE REPORTS

- **16.** Transportation Committee
 - J. Fasana provided a report for this item. The Transportation Committee convened this month to discuss the San Gabriel Valley Transit Feasibility Study, the proposed FY 2020-2021 Metro budget, and the draft Metro Goods Movement Strategic Plan. Comments to the Metro Long Range Transportation Plan are also due in mid-July. Mr. Fasana also directed SGVCOG staff to forward the Goods Movement Strategic Plan presentation to members of the Governing Board.

17. Homelessness Committee

B. Shevlin provided a report for this item. The Homelessness Committee is recommending the Governing Board to approve Item 28, Award of Funding for Pilot

Programs (Homeless Services and Activities). The committee also received a presentation on the Pasadena Outreach Response Team at the recent meeting. Ms. Shevlin recommended SGVCOG staff to include a specific item on reports from the San Gabriel Valley Regional Housing Trust in future Governing Board meetings.

18. Energy, Environment and Natural Resources (EENR) Committee

D. Bertone provided a report for this item. The EENR Committee convened this month to discuss wildfire operations in the Angeles National Forest, Southern California Regional Energy Network (SoCalREN) Public Agency Programs, and Southern California Edison's recent rate increase proposal.

19. Water Committee

D. Mahmud provided a report for this item. The Water Committee convened this month to review a presentation on PFAS chemicals and voted to recommend the Governing Board to support H.R. 535 (Dingell). PFAS chemicals can stay and accumulate in the human body; however, they can be treated in granular activated charcoal systems.

T. Sandoval provided a report for this item. The committee convened this month to approve support services tasks and the amendments necessary for the SGVCOG's capital projects to proceed. Services include community outreach, property acquisition, contracts legal support, state representation, and risk management support.
