SGVCOG Governing Board Appoints San Gabriel Valley Regional Housing Trust Board of Directors

On Thursday, April 23, 2020, the SGVCOG Governing Board convened to confirm the appointments of representatives that will be serving on the San Gabriel Valley Regional Housing Trust Board of Directors. The Trust was officially formed in February 2020 as a joint powers authority to plan and construct housing units for individuals experiencing homelessness and individuals with extremely low, very low, and low-income within the San Gabriel Valley. The SGVCOG Governing Board bears the responsibility of appointing the Trust's Board of Directors. The appointees are comprised of six individuals that represent the Trust's member jurisdictions and two individuals that are housing or homeless experts:

Field Operations Resume June 1st

The Census Bureau suspended 2020 Census field data collection activities in March, but will reactivate field offices beginning **June 1, 2020**.

Self-Response Extended to October

As a result of Census Bureau seeking relief to deliver final apportionment counts, the self-response deadline has been extended to **October 31, 2020.**



Timeline Adjustments



Apportionment counts are expected to be delivered to the President by **April 30**, **2021** and redistricting data will be delivered to the states by **July 31**, **2021**.



SGVCOG Offers Virtual Residential and Commercial Energy Assessments to San Gabriel Valley Cities

Through the San Gabriel Valley Energy Wise Partnership (SGVEWP), SGVCOG staff provides free residential and commercial energy assessments to San Gabriel Valley residents, businesses, and nonprofits. The Clean Mobility Options Pilot Voucher Program provides funding for zeroemission car-sharing, bikesharing, innovative transit services, and ride-ondemand services in historically underserved communities. The program will begin accepting Community Transportation Needs Assessment applications as early as June 1st and approve applications on a first-come, first-serve basis until funds are committed.
