SGVCOG Proposes Strategic Plan

At the February Governing Board meeting, the draft update to the SGVCOG Strategic Plan was presented to board members for feedback and review. Based on feedback and input, including a survey and workshop, five strategic goals were developed, including transportation, homelessness, water, environment, and member support and communications. These five areas represent the existing policy committee structure of the SGVCOG. Each strategic goal has its respective strategies and performance indicators to allow for the implementation and tracking of success for the revised strategic plan. Details of each strategic goal can be found on the next page. The Governing Board is scheduled to adopt the updated strategic plan in March. SGVCOG Strategic Plan Proposed Goals



Transportation Secure funding for and ensure the timely implementation of regional priority transportation projects and support regional transportation planning efforts.

- Serve as a resource to member agencies to deliver large capital projects
- Secure funding for regional transportation priorities
- Support member agencies in managing new transportation technologies in manner that balances mobility and safety

Homelessness



Support member agencies' efforts to implement programs and projects related to homelessness and advocate for resources to address homelessness in the San Gabriel Valley.

Strategies

- Support member agencies in implementing homelessness solutions
- Serve as a forum for member agencies to share best practices related to homelessness
- Facilitate local coordination of service delivery among member agencies

Water




Support regional water resiliency and assist cities in addressing stormwater MS-4 permit requirements, with an emphasis on Measure W Implementation and identification of regional solutions.

Strategies

- Advocate for regulatory and legislative changes that facilitate member agencies' ability to comply with water and stormwater regulations and reduce costs
- Secure funding for regional projects that promote water resiliency
- Serve as a resource to member agencies to deliver large capital projects

Environment





- Continue to implement energy efficiency programs for member agencies through regional partnerships
- Coordinate regional planning projects that support regional environmental goals
- Support member agencies in implementing clean energy, open space, and air quality projects

L.A. County 3rd Annual Homeless Initiative Conference



The Los Angeles County Homeless Initiative held to 3rd Annual Homeless Initiative Conference on Thursday, February 7, 2019 at the Millennium Biltmore Hotel in Downtown Los Angeles. The event brought together more than 800 key stakeholders to reflect on recent achievements, identify lessons learned, and explore challenges and opportunities for the years ahead. The Conference featured various panels and breakout sessions that are intended to facilitate discussions around emerging issues that are critical to the success of the Homeless Initiative. CNRA Green Infrastructure Grant Announcement



The California Natural Resources Agency (CNRA) has released its draft guidelines for the Green Infrastructure program for public comment. The program, funded by Proposition 68, will fund multibenefit green infrastructure projects in or benefiting disadvantaged or severely disadvantaged communities. Public comments and recommendations from stakeholders will be considered for adoption by the Secretary for Natural Resources. CalRecycle's SB 212 Informal Rulemaking Workshop



SGVCOG staff attended California Department of Resources Recycling and Recovery's (CalRecycle) SB 212 informal rulemaking workshops on January 30th and February 27th. These informal rulemaking workshops covered the timeline and the seven articles of the bill's regulatory languages, which include details on regulating covered entities, stewardship organizations, stewardship plans, as well as definitions of key terms mentioned in the bill language. CalRecycle is encouraging cities to send all public comments regarding the first three articles to PharmaSharps@CalRecycle.ca.gov at their earliest convenience. SGVCOG Launches New Energy Work Group











On February 14, 2019, SGVCOG launched its first City Staff Energy Work Group of the year. Seventeen representatives from various member agencies and entities met at the Monrovia Community Center to discuss ongoing and possible energy efficiency projects to help lower the energy usage levels in the San Gabriel Valley region. The meeting consisted of two presentations covering the overview of the San Gabriel Valley Energy Wise Partnership as well as benchmarking and Assembly Bill 802 guidelines. Work Group meetings serve as a platform for member agencies to share energy efficiency projects and best practices with one another. The Work Group is expected to meet every other month for the remainder of the year and cities are encouraged to attend and participate at these meetings to share energy efficiency knowledge and projects.
